



**WAIVER OF CLAIMS, RELEASE OF LIABILITY AGREEMENT.**

BY COMPLETING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. PLEASE READ THIS CONTRACT CAREFULLY.

- 1. I wish to participate in Game On Sports & Entertainment ("Game On") sports activities and events. I understand that my execution of this Waiver and Release is a prerequisite for participation. I further understand that the inherent risk of injury from such sports activities is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist.
- 2. I understand that in order to be allowed to participate, I agree to assume all risks and to release and hold harmless Game On, and their officers, agents, employees, assigns, successors in interest, contractors, vendors (and their agents), agencies, sponsors, officials and volunteers, other participants, owners and lessors of the facilities & premises used to conduct such activities and events.
- 3. I intend by this Waiver and Release to release, in advance, and to waive my rights and discharge all the persons and entities mentioned above, from any and all claims for damages for death, personal injury, property damage, expense and related loss, including loss of income which I may, or my next of kin may, suffer as a result of my participation in this activity, or which may hereafter accrue to me as a result of my participation in Game On, even though this liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective property or equipment owned, maintained, borrowed or controlled by them or because of their possible liability without fault. I understand and agree that this Waiver and Release is binding on my heirs, assigns, and legal representatives and I agree to waive any and all such claims that I have or may in the future against Game On, its successors and assigns.
- 4. I understand that I am solely responsible for my health and safety, including those of the other participants, and acknowledge that I am physically capable of participating in these sports activities and events. I further acknowledge that I am 15 years of age at the time of signing this Waiver and Release and that I am a Canadian citizen. Any participant aged 15-17 requires a parent/guardian to co-sign the Waiver and Release Form.
- 5. I agree to allow Game On to use my name and likeness for any purpose related to advertising or promotion of Game On in perpetuity in all forms of media now and forever known.
- 6. I also hereby acknowledge and agree to abide by the rules of the sport and policies of Game On. In doing so, I acknowledge and agree that at no time will unsportsmanlike conduct, physical abuse, verbal abuse, disrespect to officials or other participants, over-aggressive play, and/or arguing with Game On staff be tolerated and that if I do not comply with the rules and policies that I may be suspended and/or expelled from the league without a refund. Game On also reserves the right to exclude intoxicated or disorderly participants from any, and all, portions of any activity or event without a refund. I further acknowledge only my team captain may approach any league official or convener or opposing captain regarding concerns surrounding the game. Should any concerns arise, it is my responsibility to notify my captain immediately to help resolve the problem.
- 7. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.
- 8. I have carefully read this Waiver and Release and fully understand its contents. I am aware that this is a RELEASE OF LIABILITY and a contract between me and the persons and entities mentioned above and sign it freely and voluntarily without any inducement.
